ORDERED that the order on certification dated December 28, 2008, granting poor person status to the appellant John W. is hereby amended to include a direction to the stenographer(s) and/or the transcription service(s) to promptly to make and certify two transcripts of the proceedings on September 18, 2007, in a proceeding entitled *Matter of Megan W.*, commenced under Docket No. N-33292/04; in the case of stenographers, both transcripts shall be filed with the clerk of the Family Court, and the clerk of the Family Court shall furnish one of such certified transcripts to counsel for the appellant John W., without charge; in the case of transcription services, one transcript shall be filed with the clerk of the Family Court and one transcript shall be delivered to the assigned counsel for the appellant John W. Assigned counsel is directed to provide copies of said transcripts to all of
