Counsel is and will be held responsible for all submissions, acts, omissions, and any other conduct in or related to this action on behalf of [Plaintiff/Defendant/Party] \_\_\_\_\_; and it is further

ORDERED that, pursuant to Section 520.11 of the Rules of the Court of Appeals and Section 602.2 of the Rules of the Appellate Division, First Department, the attorney now admitted pro hac vice shall abide by the standards of professional conduct imposed upon members of the New York Bar, including the Rules of the Courts governing the conduct of attorneys and the Disciplinary Rules of the Code of Professional Responsibility; and it is further

ORDERED that the attorney now admitted pro hac vice shall be subject to the jurisdiction of the Courts of the State of New York with respect to all acts, omissions, or other conduct occurring during or in relation to this matter; and it is further

ORDERED that the Court shall be immediately notified by any/all counsel contemplated in this Order if any matter or event in this or any other jurisdiction affects the standing as a member of the Bar of the attorney now admitted pro hac vice or New York Counsel.
