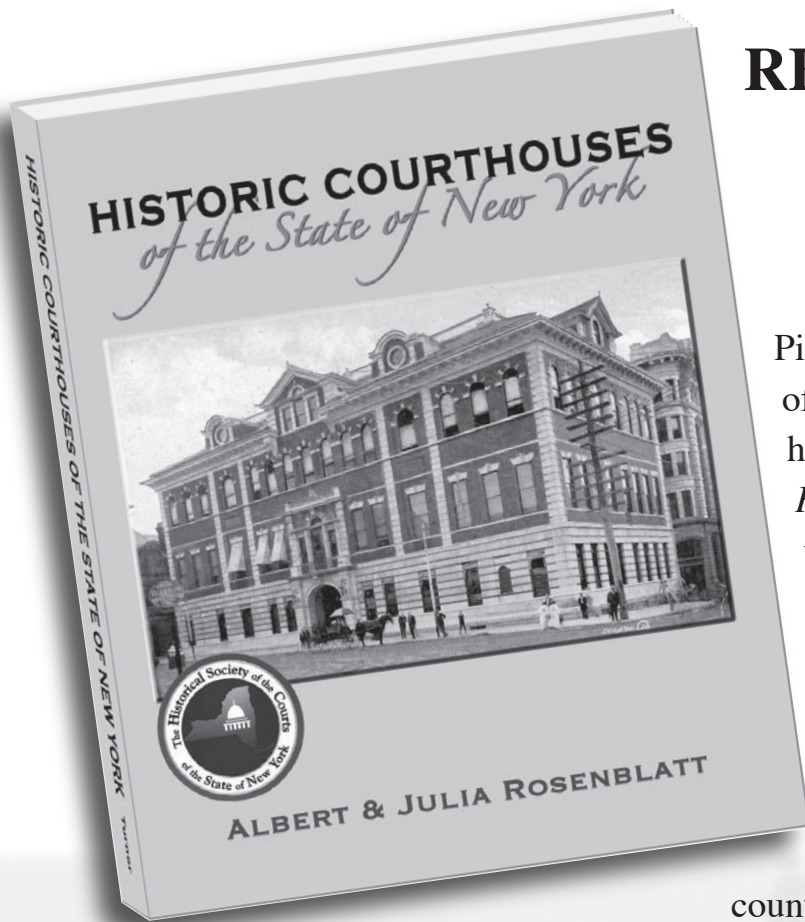


RESERVE YOUR LIMITED EDITION COPY BY MARCH 1, 2006
