The Seattle Police Department is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in <u>State v. Ward</u>, which authorizes law enforcement agencies to inform the public of a sex or kidnapping offenders release when; in the discretion of the agency, the release of information will enhance public safety and protection.


The individual who appears on this notification has been convicted of a sex or kidnapping offense that requires registration with the sheriff's office in the county of their residence. Further, their previous criminal history places them in a classification level which reflects the <u>potential</u> to re-offend.

This sex or kidnapping offender <u>has served</u> the sentence imposed on him by the courts and has advised the King County Department of Public Safety that he will be living in the location below. <u>HE IS NOT WANTED BY THE POLICE AT THIS TIME.</u> THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

The Seattle Police Department has no legal authority to direct where a sex or kidnapping offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he chooses.

Sex and kidnapping offenders have always lived in our communities; but it wasn't until passage of the Community Protection Act of 1990 (which mandates sex and kidnapping offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex or kidnapping offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notifications. We believe the only person who wins if community notification ends is the sex or kidnapping offender, since they derive their power through secrecy.

Barlow, Alan Paul W M 12/9/42

Age: 57

5'9", 165 pounds, graying hair, blue eyes. No known scars, marks, or tattoos.

Alan Paul Barlow was released from prison after completing his sentence for one count of Possession of Depictions of Minors Engaged in Sexually Explicit Conduct; two counts of Statutory Rape in the First Degree; two counts of Statutory Rape in the Second Degree; and two counts of Communicating With A Minor for Immoral Purposes. One of the victims was a 14 year old girl who lived in the state of New York. Barlow communicated with her in a sexually explicit manner by using a computer E-mail system. Barlow finally arranged to meet with the victim in New York and was subsequently arrested. Another victim was a female relative whom he sexually assaulted between her ages of 7 and 14. Barlow has an extensive history of sexual offending behavior with numerous minor female victims ranging in age from 2 to 17 years; and numerous adult females spanning nearly 30 years. Victims were family members, as well as females he met through his computer Internet activities. At one point, Barlow was involved with about 50 regulars via E-mail erotica, about half of them Barlow knew to be minors.

Barlow is no longer under the supervision of the Department of Corrections. He has no release conditions other than sex offender registration. Barlow has registered as a sex offender as required by law. He is living in the 6900 block of 55 Ave. S. This bulletin has been updated due to Mr. Barlow's supervision ending.

Additional sex or kidnapping offender information:

As of the date of this bulletin, there are 14,738 sex or kidnapping offenders who have registered as required (since 2/28/90) and are living in Washington State. 3,372 of these are registered to King County addresses. 1,182 are registered to addresses within the city limits of Seattle. State-wide there are an additional 3,049 sex or kidnapping offenders who are required to register and have not and are actively being pursued by law enforcement.
